All horses starting a training program with Russ Krachun Kozak Horsemanship will begin their education at the "Foundation" Program. Other programs and levels are offered after this initial program has been covered.

Horses will be educated five days a week, with Russ Krachun spending approximately 1 to 2 hours each day with the horse. This time depends on the learning capabilities of each individual horse. In the three months of horse development, Russ Krachun will spend 60 days with an average of 120 hours educating your horse.

Included in the "Foundation" program payment is full indoor board with hay, grain, feed supplements, water, shavings, clean stalls, and regular grooming after training each day.

Russ Krachun will schedule weekly updates with the owner as well as offer four private educational sessions each month with the owner and their horse.

The "**Foundation Kit**" is an essential part of the success in the education within this first level of training, this equipment has been designed to connect and support the methodology used within the "Foundation" program. The "Foundation Kit" will be offered to the horse owner for sale during the course of the equine education with a discount of 10%. The "Foundation Kit" includes the following: Rope Halter, 15 foot Horsemanship Rope, Horsemanship Wand with Flag and String, Lasso, Lasso Bag, Leather Gloves, and "Discover Horsemanship Philosophy & Methodology in the Round Pen" Book. Regular retail price is \$315.99

Payment Options:

\$1,500.00 each month – 3 month minimum

Option Two: Prepay half of the entire three month "Foundation" equine education package plus HST. The remaining balance is due prior to the start of the second month of training and save 5% off. A savings of \$225.00 (pay \$2,137.50 plus HST start of the first month of training, and balance of \$2,137.50 plus HST is due start of the second month of training)

Option Three: Pay a monthly payment for the "Foundation" equine education package of \$1,500.00 plus HST paid at the beginning of each month of training

Cancellation Policy

Russ Krachun Kozak Horsemanship requires a \$500.00 deposit for each scheduled horse development training spot that is booked in advance.

If for some reason you would like to postpone or reschedule your spot, you may do so as long as the spot can be filled. A full refund is allowed if your spot can be filled within thirty days of your training spot is to begin.

If your spot can not be filled no deposit will be refunded.

A cancellation of your reserved spot more than sixty days in advance a fifty percent deposit is refunded.

A cancellation of your reserved spot between thirty days in advance and less than sixty days in advance, twenty five percent of your deposit will be refunded.

A cancellation of your reserved spot less than thirty days, no deposit is refunded.

A horse that is involved in horse development training may require time to adjust and settle in to his or her new environment and to begin to understand the methodology used. Horses learn at different speeds and have different capabilities, horse owners are reminded that it takes time, patience, and consistent education in order for each horse to develop and learn new methodologies. Once a horse has been enrolled in a horse development program, no refund is given if the owner decides to cancel the enrollment.

Payment of Invoices

Invoices are payable upon receipt. Upon completion of this agreement, the remainder of any and all expenses shall be due and payable immediately. Once the training has completed, the horse is expected to leave the trainers facility. Each day the horse is boarded at Russ Krachun Kozak Horsemanship facility after training has been completed, the owner will be billed at the rate of \$16.00 plus HST per day.

Standard of Care:

Owner understands and accepts that normal and reasonable care to maintain the health and well-being of said horse. Care, services, and/or products not covered in boarding or training are, but not limited to; Farrier services, de-worming, vaccinations, fly-repellant, dental exams, chiropractic and other routine and emergency veterinary care.

Training of Horse:

The horseman shall educate the horse and perform all services in accordance with generally accepted professional standards. The horseman cannot and does not guarantee the effect of the training program or that any particular results will be achieved, since this depends a great deal on the individual physical and mental ability of each horse. The horseman shall furnish all labor, provide suitable facilities and care for the horse in an adequate manner with feed being determined by the horseman. The horseman has complete control over the manner of training and shall take all precautions for the proper performance thereof. Training sessions in the fee may include riding, lunging, and/or ground work. Owner may ride horse on his/her own or in lesson with the horseman provided the horse(s) in training is deemed ready for Owner to ride by the horseman. Owner may visit horse at any time during training and is encouraged to schedule weekly sessions to understand philosophy and methodology of training.

Emergency Care:

If emergency treatment is needed, the horseman will attempt to contact Owner but, in the event the owner is not reached, the horseman has the authority to secure emergency veterinary and/or farrier care. Owner is responsible to pay all costs relating to this care. The horseman is authorized as the Owner's agent to arrange billing to Owner.

Risk of Loss:

While the horse is in training with the horseman, the horseman shall not be liable for any injury, sickness, theft, or death suffered by the horse of any other cause of action arising from or connecting to the training of the horse. Owner fully understands that the horseman does not carry any insurance for any horses not owned by the horseman for training or for any other purposes, for which the horses are covered under any public liability, theft, or equine mortality insurance; all risks are assumed by Owner. Owner is to hold the horseman harmless from any loss or injury to said horse. All costs, no matter how catastrophic, connected with training, or for any other reasons, for which the horse is on the premises of the horseman, are to be borne by Owner.

Hold Harmless:

Owner agrees to hold the horseman harmless from any claim resulting from damage or injury caused by said horse and agrees to pay legal fees incurred by the horseman in defense of a claim resulting from damage by said horse.

Entire Agreement:

This constitutes the entire Contract for hire between the parties. Any modifications or additions must be made in writing and signed by all parties to this Contract for hire.
